

MODIFICATION AND AMENDMENT OF
AMENDMENT TO DECLARATION OF CONDOMINIUM
OF THE ARROWWOOD CONDOMINIUM

WHEREAS, the parties signatory hereto did, on November 19th, 1967, execute an Agreement entitled "Amendment to Declaration of Condominium of The Arrowwood Condominium", (hereinafter called the "Amendment") which said Amendment changed the legal description of the property demised under that certain Long Term Lease therein more particularly referred to, and inasmuch as said leased property affects the Declaration of Condominium (hereinafter called the "Declaration") and the By-Laws of The Arrowwood Condominium (hereinafter called the "By-Laws"), said Declaration and By-Laws were likewise amended; and

WHEREAS, there was a scrivener's error in setting out the legal description of the property intended to be demised by said Long Term Lease and the parties are desirous of amending the Amendment so as to reflect the proper legal description in said Long Term Lease, Declaration and By-Laws;

NOW, THEREFORE, in consideration of the premises, the parties signatory hereto do hereby amend the Amendment as follows:

1. The legal description appearing in Paragraph 1 of the Amendment should be deleted and the following legal description inserted in lieu thereof, to wit:

"An undivided interest in:

"Parcel 6 and Parcel 7, less the North 250.50 feet of said Parcel 7, of TALLWOOD AMENDED, according to plat thereof recorded in Plat Book 64, page 39, of the public records of Broward County, Florida."

2. Eliminate the words "except that portion thereof as is contained in Parcel 6 of said TALLWOOD, AMD." appearing at the end of Paragraph 2 of the Amendment and insert in lieu thereof the

following, to wit:

"except that portion thereof as is contained in Parcel 6 and Parcel 7, less the North 250.50 feet of said Parcel 7, of said TALLWOOD AMENDED.

3. In paragraph 4 of the Amendment delete the legal description contained therein and insert in lieu thereof the following:

"Parcel 6 and Parcel 7, less the North 250.50 feet of said Parcel 7, of TALLWOOD AMENDED, according to plat thereof recorded in Plat Book 64, page 39, of the public records of Broward County, Florida."

4. Subject to the amendments contained in the Amendment and the Modification and Amendment thereto contained herein, the Declaration, By-Laws and Long Term Lease shall be and remain in full force and effect.

5. This Agreement has been executed in counterparts, all of which, taken together, shall be deemed to set forth the understanding and agreements and covenants of the parties signatory to any such counterpart.

6. Charles L. Dickes and Bertina M. Dickes, the present owners of Unit No. 104, do hereby acknowledge that they have received a copy of the Amendment which was executed by Amelia M. Weber, their predecessor in title and fully confirm, ratify and approve the contents of the Amendment as amended by this Agreement.

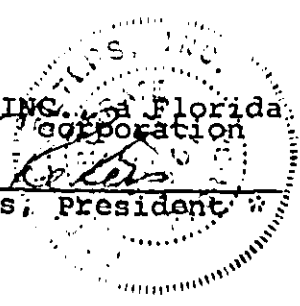

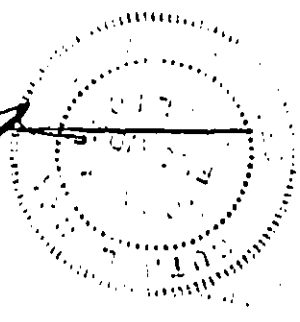
